WHEREAS:		

- A. Ruralco Property SAL is properly Licensed and entitled to undertake an Auction for the Sale and Purchase of Real Estate in the State of Victoria.
- B. Ruralco Property SAL intends to offer for sale by public auction the land more particularly described in the draft Contract for Sale and Purchase provided herewith.

- C. The Auction will be conducted live and via the medium of an online sale through the existing interface auction facility provided by Auctionsplus Pty Ltd. ("AuctionsPlus System")
- D. The participant acknowledges that the Auction will take place live and via the computer based bidding facility as is provided in the AuctionsPlus System.
- E. Ruralco Property SAL has provided to the participant by way of electronic means all documentation required to be provided, displayed or produced by an Agent undertaking the sale of real estate by Auction.

THE PARTICIPANT NOW ACKNOWLEDGES AND AGREES as follows:-

- 1. The participant has been provided with and received a copy of:-
 - (i) A Contract for Sale and Purchase;
 - (ii) The Section 32 Statement relevant to the said Contract;
 - (iii) Auction Terms and Conditions;
- The Participant will provide to Ruralco Property SAL a photographic means of identification comprising:-Drivers Licence/Passport.
- 3. To participate in the online Auction the Participant will pay a (refundable) participation fee of ONE HUNDRED DOLLARS (\$100.00) by way of a credit card debit from an Australian Bank.
- 4. The participant grants to Ruralco Property SAL its authority and power of attorney to execute a Contract for Sale and Purchase upon the Participant being nominated by Ruralco Property SAL as the successful Purchaser.

 - (iii) Confirm the Participant has the ability to comply with all covenants and conditions contained in the Contract for Sale and Purchase;
 - (iv) Agree to bid at the notified increments as nominated by the Auctioneer.
- 7. The Participant acknowledges:-
 - To have received and read those documents referred to in paragraph 1 hereabove.
 - (ii) That is has satisfied itself:-
 - (a) By physical examination as to the state of repair, condition and quality of the land offered for sale and the improvements thereon all of which is sold as it stands and as inspected as at the date of this Agreement.
 - (b) By enquiry to all relevant statutory authorities and Governmental authorities as to the use to which the land may be put and its zoning and planning restrictions.

- (c) Is aware of any notices orders and requisitions issued in respect of the land and whether those notices, orders and requisitions have been satisfied.
