1. As the listed assessor, I am responsible for the objective and accurate assessment of the livestock listed for auction
2. To professionally conduct assessments with Parallel Assessors with respect to principles of the AuctionsPlus Operating Conditions and Assessment Manuals
3. I will only nominate a Parallel Assessor who is present and actively involved in the assessment process, including:
  - a. Compiling the objective measures required for an assessment (weight, fat score, age/dentition, wool length, etc)
  - b. Drafting stock as appropriate into sale mobs
  - c. Discussing with the Vendor the management and history of the stock as required on the assessment
  - d. Removing any stock not fit for sale/transport
  - e. Taking suitable photos and videos of the stock on-farm
  - f. Obtaining a signature from the Vendor on the assessment form
  - g. Determining appropriate weight adjustments and Dressing Percentage
  - h. Uploading the Assessment and media to the AuctionsPlus website
  - i. Determining the Reserve and Starting price for auction, based on Vendor expectations and market conditions
4. To endeavour for myself or the Parallel Assessor to attend delivery of stock where possible, to ensure:
  - a. Stock are consistent with the assessment
  - b. All stock are Fit to Load
  - c. Even lines where stock are sold as a "run out the gate"
5. To proactively resolve any claim of misdescription post-delivery, upholding the AuctionsPlus Operating Conditions and considering agency best practice, and to include the Parallel Assessor in the process of resolution
6. To only recommend a Parallel Assessor for Accreditation when, using my best judgement, they are competent and capable of completing a professional livestock assessment
7. I will complete ongoing Professional Development in relation to this Endorsement as required by AuctionsPlus
8. This Endorsement is subject to ongoing review may be revoked by AuctionsPlus at any time based on feedback and performance
9. I will uphold the AuctionsPlus system and my own performance as an Assessor to the highest level of integrity possible
