Delivery of Sale Bulls

This will be co-ordinated by the Sullivan Livestock team. There will be local carriers available on Sale day. All due care is taken during transit of purchased animals however buyers are responsible for insurance against injury or death at the fall of the hammer.

Insurance is available through Think Insurance. Buyers must also fill out a delivery form with delivery instructions.

Sale day Safety

We have made every effort to ensure our Bulls are quiet, however Sale day adds extra pressure. Bulls can be unpredictable therefore people enter pens at their own risk and we request children under 16years are prohibited from entering pens.

Vaccinations

Bulls have been vaccinated with 3 Germ blood twice, 7 in 1 and 3 Day Sickness.

Fertility testing

This years Sale Bulls have been Semen tested and Bull Soundness Evaluated by Dr Ced Wise.

Breedplan & Performance Data

Breedplan EBVs of the sale lots are listed on page 6 and 7.

Averages for both the Spring and Autumn groups is also included for reference.

These traits include:

Birth Weight (kg): The animal's actual weight on the day it is born (please note this figure is not adjusted for Gestation Length.)

Adjusted 200DW, 400DW, 600DW (kg): The weight of each animal adjusted for the three stages of the animal's age.

Scrotal Size (SCROT) and ultrasound measurements Fat (P8, Rib), Eye Muscle Area (EMA) and Intra Muscular Fat (IMF) were taken on the 3rd June 2015.

Genetic Information

All breeds of cattle, in fact all mammals including humans, have undesirable genetic conditions. Fortunately, advances in molecular genetics have facilitated the development of DNA tests for their management.

AM, NH, CA and DD are simply inherited recessive conditions. This means that a single pair of genes controls the condition. For this mode of inheritance two copies of the undesirable gene need to be present before the condition is seen; in which case you may get an abnormal calf. For the condition to be expressed the undesirable gene needs to be present on both sides of the pedigree and both the sire and dam need to be a carrier. The genetic status of animals is being reported

using five categories:

AMF Tested AM free

AMFU Based on pedigree AM free – Animal has not been tested

AM__% __% probability the animal is an AM carrier

AMC Tested AM-Carrier

AMA AM-Affected

For NH, CA and DD simply replace AM in the above table with NH or CA.

Question: Crossbreeding and AM, NH, CA and DD

I use Angus bulls in a cross-breeding program. Have the genetic conditions been found in other breeds? What is the risk of an affect calf if joining to cows of another breed?

Short Answer:

If the females you are using to crossbreed with have:

1. No Angus content - you can use AMC, AM__%, AMFU or AMF bulls without expecting any affected calves (substitute with NH or CA for same result)
2. Some Angus content - you should use AMF or AMFU bulls to avoid any problems.

Note: Be aware that some breeds have had infusions of Angus in the past.

What Are HBR & APR Bulls?

HBR - Herd book registered. These bulls are stud registered with the Angus Society and are transferable for stud duties.

APR - Angus Performance Registered are performance recorded bulls unable to be transferred for stud duties.

A Brief Guide to Angus Group Breedplan

Angus GROUP BREEDPLAN is an advanced genetic evaluation system that provides a genetic description of Angus cattle for a comprehensive range of traits influencing fertility, growth and carcass performance. It provides predictions of the genetic merit of individual animals called Estimated Breeding Values (EBVs). EBVs are based on all available pedigree and performance records provided by breeders in Australia and New Zealand, along with available overseas genetic information.

EBVs are expressed in the units of measurement for each particular trait, and are shown as +ive or -ive differences from the breed base. The average EBV for different traits changes over time as the breed makes genetic progress. The averages for calves born in 2018 are shown below. These averages provide a useful benchmark for comparison of EBVs for individual animals.

* Breed average represent the distribution of EBVs across the 2018 drop Angus and Angus-influenced animals analysed in the Mid June 2020 genetic evaluation

A Brief Description Of EBV's

Calving Ease DIR (%) - Estimates of the genetic differences between animals in the ability of their calves from two year old heifers to be delivered without assistance. (Higher positive values are more favourable.)

Calving Ease DTRS (%) - Estimates of the genetic differences between animals in the ability of their calves from two year old daughters to be delivered without assistance. (Higher positive values are more favourable.)

Gestation Length (days) - Estimates of genetic differences between animals in the number of days from the date of conception to the birth date.

Birth Wt (kgs) - Estimates of genetic differences in calf birth weight.

200 Day Wt (kgs) - Estimates of the genetic differences between animals in liveweight at 200 days of age.

400 Day Wt (kgs) - Estimates of the genetic differences between animals in liveweight at 400 days of age.

600 Day Wt (kgs) - Estimates of the genetic differences between animals in liveweight at 600 days of age.

Mature Cow Weight (kg) - Estimates of genetic differences between animals in cow weight at five years of age.

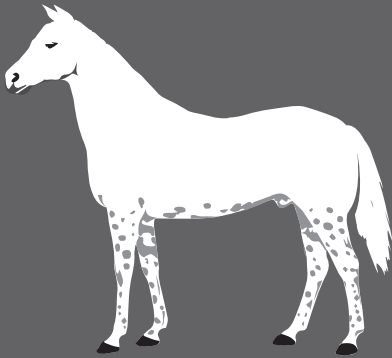
Milk (kg) - Estimates of the genetic differences between animals in milk production, expressed as variation in 200 day weight of daughters calves.

Scrotal Size (cm) - Estimates of the genetic difference between animals in scrotal circumference at 400 days of age.

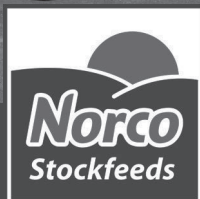

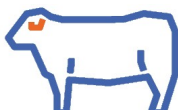

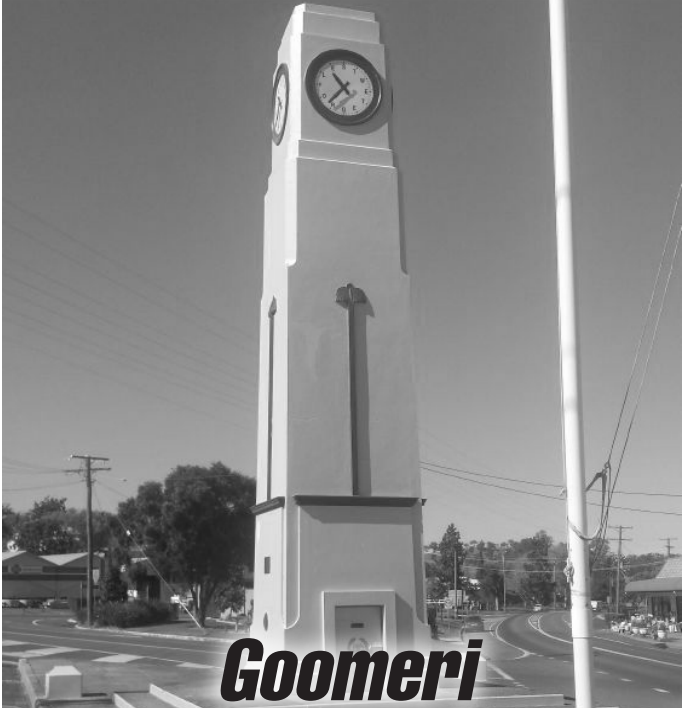

IMPORTANT NOTICE

All bids shall be treated as offers made upon

1. The highest bidder shall, subject to Conditions 2, be the purchaser provided that the vendor reserves the right to bid either by himself or through his agent or auctioneer and should any dispute arise among the bidders for any lot, during or immediately after sale of the lot, it shall be settled at the auctioneer's absolute discretion who may, should one of the disputants advance, put the lot or lots up again. The bidding from time to time shall be regulated by the auctioneer and no bid shall be retracted.
2. 6.
