

LAMBPLAN Maternal Indexes

Maternal Carcase Production+ (MCP+)



The Maternal Carcase Production + (MCP+) index is similar to the Maternal Carcase Production (MCP) index, with the addition of both wool and worm egg count. This index targets self-replacing production systems where maintaining adult weight and fleece weights are seen as important at the same time as improving carcase traits. A slight increase in clean fleece weight is expected. This index aims to reduce WEC as it is assumed in the index most enterprises are located in high rainfall areas and/or high input management systems. The contribution of each trait to economic gain is expressed in the graph along with the predicted genetic gain over 10 years.

COMMERCIALLY PROVEN

Welcome to our third annual on property sale. In 2021 we are proud to be offering 120 maternal composite rams for auction, all above industry average in MCP+ (Maternal Carcase Production+) index.

With the early break in the season we were able to join onto fresh green pastures, giving us excellent scanning results – our commercial ewes a phenomenal 193% (including dry's). We focused heavily on lambing in smaller mobs and Feed on Offer (FOO) to increase lamb survivability, with the result being some excellent lamb marking results. Our twins marked up to 198% (95% survival), while our triplets marked up to 240% (82% survival).

With lamb and sheep prices remaining strong throughout the year pushed by re-stockers after the drought, and with the high cost of buying in first cross ewes, adopting a self-replacing system is a particularly good option for prime lamb production.

We have introduced some exciting industry leading genetics and our breeding program continues to be commercially focused.

Producing more lambs is the main profit driver in our program.

Our genetics offer you:

- sheep that produce more kg per ha = increased profit
- highly fertile maternal ewes with excellent mothering ability = better lamb survival
- early maturing, ewe lambs can be joined at seven months = faster return on asset
- high yielding lambs: In May 2020 Salway Maternal Lambs sold to TFI Tamworth, weighing 58.94kg and dressing at 30kg – an impressive 50.9 dressing percentage.

We place a high emphasis on physical selection and pride ourselves on providing a performance tested product. All of our 2021 rams have been independently assessed for structural soundness by Tim Lawrence of Advanced Livestock Services. Sale rams have been used as ram lambs under commercial conditions and have been vet checked by Dr Joanna Bacon.

This sale catalogue includes structural scores, along with definitions of the indexes and measurements that we use (MCP+ index and ASBVs) plus a full list of our reference sires.

Our annual sale would not be possible without a fantastic team around us. Our sincere thanks to Jacob and Tu for all of their hard work throughout the year, to the team at Nutrien Boulton's for their assistance with the sale, and to Walcha Hospital Auxiliary for delicious cakes and cooking lamb burgers!

AUSTRALIAN SHEEP BREEDING VALUES (ASBV'S) EXPLAINED

An ASBV's is an estimate of the genetic potential a sheep has to pass on to its progeny. ASBV's are available for a range of economical important traits and are designed to be used in conjunction with visual selection. The appearance and performance of an animal is a combination of its genes and the environment in which it is raised (e.g. the amount and quality of feed, single or twin or twin birth type.) ASBV's account for these environmental effects, allowing the comparison of sheep based on the genes they will pass on to their progeny. It is important to remember when selecting sheep you are choosing the genes, not the environment.

BIRTH WEIGHT (BWT)

Rams with more negative BWT ASBVs produce lambs which are lighter at birth (kg). (BWT ASBV's estimate the genetic difference between animals in live weight at birth). Use low or negative BWT for maiden ewes.

WEANING WEIGHT (WWT)

Estimates the genetic difference between live weights at 100 days. Rams with a more positive ASBV for weaning weight (WWT) will, on average, produce lambs with faster growth to weaning (kg).

WEIGHT (PWWT)

Post weaning weight estimates the genetic difference between animals (kg). The higher the ASBV figure the better for superior later growth of lambs.

ADULT WEANING WEIGHT (AWT)

Adult weaning weight at two years (kg).

FAT (PFAT)

Post weaning fat depth at approx. 225 days (mm). Rams with a more negative ASBV for post weaning fat (PFAT) will produce progeny that are leaner.

EYE MUSCLE DEPTH (PEMD)

Post weaning eye muscle depth at approximately 225 days. Rams with more positive ASBV's for EMD will produce

progeny that have more muscle and yield more lean meat (mm).

SCROTAL CIRCUMFERENCE (PSC)

Post weaning scrotal circumference (mm) Rams with larger testes will sire more daughters and wean a higher percentage of lambs.

NUMBER OF LAMBS WEANED (NLW)

Number of lambs weaned (%) Rams with more positive NLW ASBV's will produce daughters that wean a higher percentage of lambs.

YNLW

Number of lambs weaned % for a one year old ewe.

WEC

Worm egg count (%) – Rams with more negative WEC ASBVs produce progeny who have a higher genetic potential to resist worm burdens. Lower WEC ASBVs are desirable.

MWWT

Maternal weaning weight (kg) – Rams with more positive MWWT ASBV's will produce daughters that wean heavier lambs.

ASBVs have been generated from on the 1 December 2020 run.

HOW TO USE THE VISUAL SHEEP SCORES

The sheep structural assessment uses a 1 – 5 scoring system

- A score 1 is very good
- A score 2 is good with the animals showing slight variation from the ideal
- A score 3 is average with animals showing greater variation from the ideal
- A score 4 is poor
- A score of 5 is very poor

Note: Scores 1 and 5 are not catalogued

- A score of 1 is very straight
- A score of 2 is animals showing slight variation from the ideal
- A score 3 is ideal




