## Safe Use Notice (SUN)



This document is relevant to any Category 2 & Category 3 plant and all other uncategorized lots listed in any Nutrien Ag Solutions Auction, whether on-site or via the AuctionsPlus platform;

As a registered bidder, in submitting a bid on my own behalf or on the behalf of another registered bidder or individual, I as the buyer or buyer's agent accept that the item purchased is not suitable for the workplace. As the buyer I acknowledge and accept responsibility for ensuring that all machinery and plant meets all workplace occupational health and safety requirements as the registered buyer.

I acknowledge that the following have been clearly identified and explained to me and that I shall at no time hold Nutrien Ag Solutions, its agents or vendor responsible for any defect, fault or the capacity of the plant or machinery. I guarantee that I shall be responsible for the worthiness of the plant OR machinery.

By bidding in a Nutrien Ag Solutions Auction whether on-site or via the AuctionsPlus platform, I acknowledge that the plant or machinery may be affected by one or more of the defects without being expressed by Nutrien Ag Solutions, its employees, Agents or Vendor and acknowledge that I shall be solely responsible as the buyer for all known or unknown defects. I accept the following disclosures and acknowledge that it is my responsibility as the registered purchaser for the following and accept that the plant may be subject to some of or all the following disclaimers, but not limited to:

- 1. Is not registered.
- 2. Is not roadworthy.
- 3. No manual or operator's manual is available.
- 4. Has not been structurally tested and <u>CAN NOT BE MOVED OR REMOVED</u> until the purchaser has obtained their own certificate of worthiness <u>OR</u> the bidder is personally satisfied with its worthiness.
- 5. Is not safe for the workplace and the operator must obtain all relevant licenses to operate the plant or machinery prior to removal at their own risk & expense.
- 6. Does not meet Occupational Health and Safety requirements.
- 7. Does not have all, any or the required safety guards.
- 8. Has no service history.
- 9. Serial or VIN numbers are not available or noted
- 10. Must be fully serviced and workshop approved by a registered OH&S compliance officer prior to placement in the workplace at the purchaser's risk & expense.
- 11. Is not pressure tested nor hydraulically tested and must not be used until proven fit for purpose
- 12. Has not been chemically tested and must not be used in the workplace until proven fit for purpose.
- 13. Is not factory complete and no parts are offered with the plant or machinery.
- 14. No warranty is implied or offered by Nutrien Ag Solutions, its agents or vendors with or for the plant and equipment
- 15. Nutrien Ag Solutions, its agents or vendors offer <u>NO WARRANTIES</u> as to performance of the plant or machinery in any environment or workplace. Suitable compliance checks will be the sole responsibility of purchaser.
- 16. The plant or machinery is purchased on the basis that the purchaser acknowledges that the item is not safe for the workplace and that they must obtain all relevant training, licensing and safety certificates prior to operating or removal of the item from the site.
- 17. The purchaser shall ensure that all plant is securely loaded or tied down prior to removal. The purchaser also warrants that they have all necessary signs, lighting & escorts to meet RTA requirements; this responsibility lies solely on purchaser or person acting on behalf of a purchasers.
