#### Biosecurity note:

It is best Biosecurity practice for all purchasers of sheep take the following precautions after purchase:

- Request the vendor to ensure the truck is hosed out with high pressure water prior to loading;
- The purchaser should inspect sheep for lameness and examine all feet for underrunning immediately after arrival on the property. Sheep should be re-examined during the 14-day period after arrival and if footrot is suspected, obtain veterinary advice urgently;
- All sheep must be placed in clean paddocks (unstocked for at least 7 days) and kept isolated for observation for as long as possible (preferably until after the next footrot spread period)
- Retain a copy of this Declaration.
